RuPay Debit Select Card Program

1. Introduction:

RuPay Debit Select variant was launched acknowledging the growing consumer behavior towards fitness, rejuvenation, nutrition and personal care. RuPay Debit Select enables the member Banks to meet their customer's aspiration on wellness and lifestyle. The below features on RuPay Select Debit Cards with effect from 1st April 2025.

2. RuPay Select Debit - Features and Benefits:

Keeping Fitness, Rejuvenation, Nutrition and Personal Care as the key aspect of RuPay Debit Select Card, we have designed the following proposition:

- 3. All the aforesaid mentioned features come with a bundled pricing of INR 250/- per card per annum. The same will be collected quarter wise from the banks based on the number of RuPay Select debit cards reported by the banks in the MCPR.
- 4. The utilization of features is capped as per the below table:

Upon breach of the portfolio level, cost to be billed to banks based on their utilization percentage. The details of the merchants and cost to the banks on feature overutilization is given in **Annexure A**. The customer journey is attached to **Annexure B**.

The utilization limits of all the features would be calculated basis:

- a) 100% of the card base at the end of the previous period; and
- b) 50% of the cards issued in the current period

The utilization report of all the features will be shared with the banks on a quarterly basis. Please note that the capping structure of the features shall be applicable to the complete RuPay Select debit portfolio of the bank and will not have any impact on an individual cardholder. An illustration of feature utilization capping is attached as **Annexure C**.

5. RuPay Select Debit - Product Fee Rebate Structure:

NPCI provides rebate to RuPay Select issuing banks in order to encourage banks to issue RuPay Select Cards which in turn reduces the fee per card for the banks.

Rebate Structure for RuPay Select Cards issued in the Current Financial Year:

For Cards issued in current FY:

Up to 25k	0%		
Greater than 25k and up to 50k	20%		
Greater than 50k and up to 100k	40%		
Greater than 100k and up to 1000k	60%

In case, if the utilization of features crosses the pre-defined capped limit at the end of the FY, the cost of the same shall be recovered from the Banks or from the available Product Fee Rebate, as the case maybe.

Please Note: The above product fee, card features, and rebate structure will be in place till the new circular with revised features are issued.

Request all the member banks to make a note of the above and provide communication to RuPay Cardholders about the features and benefits of the card.

Customer journey for redemption of Features on RuPay Select Debit cards

- The features can be redeemed on the URL- https://www.rupay.co.in/our-cards/rupaydebit/rupay-select
- 2. After logging into the tab, cardholder has to sign up with the below details:
 - a) Customer name
 - b) Card type
 - c) Card Name
 - d) First 6 digits/8 digits and last 4 digits of card number
 - e) Mobile number
 - f) E mail ID
 - g) Location
 - h) Password
- Once the password is created, cardholder can login with the registered E-mail ID &
 Password and explore the complementary benefits
- 4. Post selecting the benefit, customer has to make a Re.1 transaction using the RuPay Select Debit card to get the booking done.
- 5. The coupon details will be shared on the registered e-mail ID within 24-48 hours of transaction.

Annexure C

Illustration of Feature Utilization Capping

Utilization capping limit based on cards base would be calculated basis-

- 100% of the card base at the end of the previous FY i.e., April to March
- 50% of the new card base at the end of the current FY i.e., April to March

Illustration-

Case-1: Annual utilization rate of RuPay Select Debit Card of the bank is equal to or less than 3%. In this case, no recovery will be made on the bank for the year

Case-2: Annual utilization rate of RuPay Select Debit Card of the bank is greater than 3%. In this case, recovery will be made on the bank for the year
