Subject: Addendum to Enhancement in UPI LITE Limits

With reference to the NPCI/UPI/OC No. 138/2021-22, dated 16th March 2022 and NPCI/UPI/OC No. 169/2023-24, dated 31st August 2023, UPI LITE was introduced and transaction limit was increased from ₹200 from ₹500 respectively.

1. As per the latest notification issued by RBI on 4th December 2024 vide circular no. RBI/2021-22/146 CO.DPSS.POLC.No.S1264/02-14-003/2021-2022 with subject 'Framework for Facilitating Small Value Digital Payments in Offline Mode', for UPI LITE, the enhanced limits shall be ₹1,000 per transaction with ₹5,000 being the total limit. Replenishment of used limit shall be allowed only in online mode with AFA. Customer will further have the option to set Auto Top-up for limit replenishment as per NPCI circular, 'Introduction of Auto Top-up on UPI LITE', vide No. NPCI/UPI/OC No. 205/2024-25, dated 27th August 2024. The details of the LITE limits are as below:

Per Transaction Limit	₹500	₹1000	₹500
Total Limit at any point in time	₹2000	₹5000	₹2000

The new limits shall apply to and govern all existing NPCI circulars pertaining to UPI LITE limit (Annexure A). All the members are required to make the necessary changes pertaining to limit increase immediately.

Issuer banks live on UPI LITE shall identify all the UPI LITE accounts that have had zero transactions
in the past six months. Any balances in these dormant LITE accounts shall be refunded to the source
bank account. Issuer banks shall implement the changes by 30th June 2025.
